Dear Vacation Village Homeowners/Day Camp Parent,

Enclosed are the registration materials, fee schedules, applications and medical/physician forms for the 2015 summer session. Please be sure to share these materials and information with all the members of your household who might be interested in registering for camp. These materials are also available on the day camp page of the Vacation Village Web site at <http://www.vacationvillagehoa.com/daycamp.html>

Camp will begin on **Wednesday, July 1st and end on Tuesday August 25th, 2015.** Please note the first session will be from July 1st through July 28th and the second session will be from July 29th through August 25st. monthly rates are based on consecutive weeks only.

The fee schedule is set up to encourage "HOA" folks to sign up before March 1st.

Vacation Village Renters must first contact the office to ensure that all forms are filled out. In addition they must have a lease signed by March 1st in order to qualify for the discounted prices. We need your continued cooperation in order to ensure that we have appropriate staffing and bunk configuration. We ask everyone to please make sure to have your registration material submitted as soon as possible.

Registration must be accompanied by FULL payment. NO \$\$\$ NO CAMP. Please return the registration form and the worksheet you used to calculate your fees to the VVHOA office. No child will be allowed to enter camp without the proper forms – including the medical and physician form - completed.

A LETTER WILL FOLLOW INVOLVING THE LUNCH PROGRAM AS SOON AS IT IS FINALIZED.

Vacation Village Day Camp offers three programs.

- Camp house – Preschool program. This program has two parts.

**2 year old program** - This is for children turning 2 before July 1st. This program will be part of the camp house with an adjusted schedule of 9:30 – 3:00 (This program will be offered if 5 or more eligible children apply).

**3- 5 year old program** - All Camp house children who are in this program must be completely toilet trained. If they are not trained we will charge you an extra \$100.00. Parents must provide a birth certificate confirming the age of their child.

- **Camp Program** – This program is for children of age 6 and up to and including age 11. These children are organized into groups by school grade.
- **Teen Program** – This program is for older children ages 12 – 14. This program will be offered if 10 or more eligible teens apply.

**Dinner for Counselors** – Every household that has a child in Day Camp **MUST** provide a meal for counselors living in the dorm as well as a Shabbos meal.

If you have any suggestions, we would like to hear from you BEFORE the summer begins so that your suggestions and ideas may be considered prior to the start of camp.
